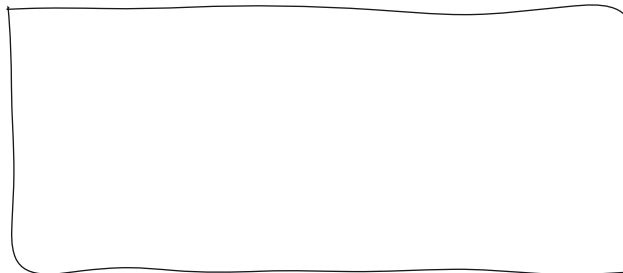

 - Death or bodily injuries to third parties: 120,202.42 euros with a maximum limit per claim of 240,404.84 euros.
 - Material damage and economic loss: 96,161.94 euros.
- **Voluntary public liability insurance**, which extends and complements the mandatory public liability insurance limits.
- **Claims for damage** caused by third parties to the insured boat or to any of its occupants.
